A dependent student for financial aid purposes whose parents refuse to support him/her and who is not eligible for a dependency override may be able to receive dependent level **UNSUBSIDIZED DIRECT LOANS ONLY**. For a student to be eligible for this special provision, the following required documentation must be submitted for consideration and processing:

- Submission of the 2026-2027 FAFSA:
  - Though the results may be received by the Financial Aid Office in a rejected status due to missing parental information, the record must be submitted and pass the federal database matches conducted by the FAFSA Processing System (FPS) to determine the student's required basic eligibility for federal aid.
- Submission of the student and parent statements below:
  - Both the student and parent must complete and sign the designated statements below. If the parent refuses to sign and date the parent statement below, an attestation to confirm the parent's refusal to provide FAFSA or verification information and/or financial support can be obtained from a third party such as a teacher, counselor, member of the clergy, or court who has first-hand knowledge of the student/parent situation – the student alone is not sufficient. The attestation should be signed, dated, and on the third party's letterhead.
