SIXTH AMENDMENT TO INSTRUCTIONAL AGREEMENT

This Sixth Amendment to the Instructional Agreement ("Sixth Amendment") is dated effective as of July 1, 2024 ("Effective Date") and is entered into by and between The University of Texas at Arlington ("UTA"), an agency and public institution of higher education established under the laws of the State of Texas, and The Arlington Independent School District ("School District").

UTA and School District entered into an Instructional Agreement dated effective August 24, 2015, which was subsequently amended by that Letter of Agreement between UTA and School District effective September 14, 2017 ("Letter") and further amended by that Second Amendment dated effective July 1, 2018, Third Amendment effective May 1, 2021, Fourth Amendment effective July 27, 2022, and Fifth Amendment effective July 1, 2023 (collectively the "Agreement").

UTA and School District now desire to further amend the terms of the Agreement as more particularly set forth below:

- 1. **Term:** The parties agree to extend the Agreement end date to July 31, 2025. Thereafter the parties may renew the Agreement by mutual written agreement.
- 2. Except as provided in this Sixth Amendment, all terms used in this Sixth Amendment that are not otherwise defined will have the respective meanings ascribed to such terms in the Agreement.
- 3. This Sixth Amendment embodies the entire agreement between UTA and School District with respect to the amendment of the Agreement. In the event of any conflict or inconsistency between the provisions of the Agreement, the Letter, prior amendments and this Sixth Amendment, the provisions of this Sixth Amendment will control and govern.
- 4. Except as specifically modified and amended herein, all of the terms, provisions, requirements and specifications contained in the Agreement remain in full force and effect. Except as otherwise expressly provided herein, the parties do not intend to, and the execution of this Sixth Amendment will not, in any manner impair the Agreement, the purpose of this Sixth Amendment being simply to amend and ratify the Agreement, as hereby amended and ratified, and to confirm and carry forward the Agreement, as hereby amended, in full force and effect.
- 5. THIS SIXTH AMENDMENT WILL BE CONSTRUED AND GOVERNED BY THE LAWS OF THE STATE OF TEXAS.
